Awards Ceremony

FPH hold an annual awards ceremony to celebrate the achievements of our new prize winners and welcome new Members and Fellows to our public health family.

Those we recognise are the public health leaders of the present, and of the future. It is through their commitment to protect, promote and advance the science of public health that we are able to drive forward our shared mission of delivering better health for all — leaving no one behind.

All who are recognised have embodied this mission, delivering outstanding public health work to protect and improve health for all in society at a time when this work has never been more critical.

Their efforts in public health, often delivered out of the spotlight, all too regularly go without the recognition they deserve – so it is important that we gather to reflect and celebrate the successes of the individuals that make up the dedicated and diverse public health workforce.

Current FPH Prizes are:

FPH Service Award

The FPH Service Award provides formal recognition for members who support us by volunteering their time and expertise through taking on a core Faculty role. These varied roles cover all aspects of Faculty business from education and training to workforce and health policy and advocacy. The FPH Service Award allows us to celebrate the long-term contributions that our members make and marks our gratitude to their dedication to the Faculty.

Sarah Stewart Brown Award for Public Mental Health

To encourage and promote leadership and innovation in public mental health in the UK among members of the public health community.

Sir John Brotherston Prize

For the best essay or research on a public health topic written by a student or young graduate.

Michael O'Brien Prize

For the highest score in the FPH Diplomate Examination.

The McEwen Award

For the highest score in the FPH Final Membership Examination.

Ann Thomas Prize

For the highest score in the Faculty's MFPH Examination by a specialty registrar based in Wales.

FPH Trainer Award

For exceptional educational supervisors.

Sian Griffiths Global Public Health Award

In recognition of the contribution of public health professionals working in global public health.

FPH Staff Award

In recognition of outstanding work by FPH staff.

Sam Ramaiah Award

For work on a public health topic that seeks to improve the health of black and minority ethnic communities or reduce health inequalities in the UK.

Synergy Award

In recognition of a strong commitment to, or success in, collaborative working with other organisations on shared public health objectives.

Alwyn Smith Prize

For outstanding contribution to public health research or practice.

Bazalgette Professorship Champion of Evidence Award

In recognition of the public good that results from the translation of public health research into services, infrastructure and the environment.

Cochrane Prize

Awarded to support an educational activity in the field of public health.

June and Sidney Crown Award

In recognition of young members of FPH (particularly those working within the National Health Service) to gain experience or further training outside the United Kingdom.

Littlejohn Gairdner Award

In recognition of outstanding potential in making a contribution to public health in Scotland.

Wilfrid Harding Prize

In recognition of outstanding contribution to the Faculty.

Elizabeth Russell (Scotland)

In recognition of a collaborative approach to addressing a public health issue
