The Clinical Governance and Revalidation Division sits within the Health Equity and Clinical Governance Directorate in UKHSA. The Division:

- Leads the implementation of a UKHSA health protection and quality governance strategy.
- Ensures high consultant professional standards, including overseeing arrangements for professional appraisal and revalidation for GMC, GDC and UKPHR registrants and supporting the Responsible Officer in the delivery of their role.
- Provides leadership and oversight of UKHSA's post-graduate training activities.
- Hosts UKHSA's Caldicott Guardian and supports the Caldicott Guardian function ensuring safe sharing of patient identifiable information under Caldicott rules.

There are opportunities for placements in any of the teams within the Division and it may be possible to undertake placements that work across two teams.

Within the **Clinical Excellence and Quality team** there are opportunities for senior registrars to deliver a portfolio of work linked to the development of clinical and health protection governance arrangements in support of UKHSA's Clinical and Health Protection governance and Quality strategy launched in early 2024.

The specialty registrar will join the central Clinical Excellence and Quality team and will gain experience of a systematic approach to improving and assuring public health practice in a complex health organisation.

Portfolio work could be in the development of new quality improvement initiatives working with the Plan-Do-Study-Act cycle on cross-UKHSA clinical and health protection priorities and risks; to develop exemplar projects showcasing novel use of a systems approach to organisational learning from public health practice and the assessment of clinical and health protection risks; the development of new approaches to continuous quality improvement working with health system partnerships; the design and roll out of the cross-UKHSA training offer for quality; or the further development of UKHSA's quality monitoring systems.

There will also be an opportunity to contribute to or lead development work to support the continued establishment of a multiprofessional corporate clinical and health protection quality team

Within the **Caldicott and Information Governance team** there are opportunities to gain in depth learning about the role and function of the Caldicott Guardian and the application of legislation and guidance relating to information governance. The specialty register will work with the team to lead decision making to undertake data processing under Regulations 3 & 7 or Caldicott regulations, audit existing activity, integrate processes with wider GDPR requirements and/or develop policy for example for genomic data; and establish the evidence base on the service user expectation and ethics of sharing PII data.



Within the **Postgraduate Training Faculty** there are opportunities to lead the development of educational initiatives to support staff development and evaluate educational interventions.

With the Appraisal and Revalidation team there is opportunity to facilitate appraisee training and appraiser networks; support the professional leadership of medical and public health specialists across UKHSA; develop the support for appraisal and revalidation offered to UKPHR registrants, and/ or develop multi-professional UKPHR registration policy and processes.

**EQUAL ACCESS ARRANGEMENTS** (Please explain how you would ensure this placement is accessible to all suitable trainees across the UK)

UKHSA Clinical Governance and Revalidation Division supports remote and hybrid working so trainees can join from all locations. Some travel to London or other locations may be advantageous and will be discussed with trainees on application. CG&R also supports flexible working as per existing arrangements, as well as part time and split placements.

There is no out of hours requirement for the post and trainees may stay on existing regional health protection on call rotas as agreed with their training programme.

There will be two rounds of placement applications per year. If more applications are received than placements available, then placements will be offered based on a competitive interview process. Trainees should contact the placement to receive details on the next proposed recruitment round.

- Review and support for implementation of clinical governance policies
- Develop cross-UKHSA priority clinical/public health audit projects working with expert leads
- Develop and support implementation of principles and quality criteria/standards for the delivery of UKHSA health protection advice services
- Evaluate the programme of support offered to potential UKPHR applicants and outcomes in progression to specialist registration
- Lead work to develop a workforce strategy for public health and scientific disciplines across UKHSA
- Lead the Caldicott Guardian function and decision-making processes for PII data sharing, advise on data sharing queries, review the evidence base on public expectations regarding sharing PII data
- Lead a programme of activity to develop new consultant skills, and networks including supporting UKPHR registrants (specialist and practitioner) policy and processes, and advise on national policy to UKPHR

- 2. Obtain TPD support to apply for this Nationally Available Training Placement
- 3. Have passed the FPH Membership Examinations prior to starting their training with Clinical Governance and Revalidation
- 4. Submit a CV (max 2 sides A4) and a covering email outlining their interest in a project or placement, and the main learning outcomes sought

If more applications are received than placements available, interviews will be held. Training offers will be determined by:

- Interest and experience in clinical governance, professional regulation, and postgraduate training
- Alignment of Registrar training needs to the work of the division and the divisional business plan
- Availability and capacity of educational supervision
- Geographical, Diversity and Inclusion equity
