**\* FPH Reasonable Adjustments**

FPH is continuing to trial a schedule for reasonable adjustments to enable candidates to receive an earlier decision if they wish to. There are now two deadlines for submitting Reasonable Adjustment paperwork. The early deadline is on 23 July and the later, second submission deadline is as normal, with an absolute deadline for receiving paperwork on the application closing date.

Please note that both the professional report and TPD/employer letter must be sent to the Exams Coordinator by this deadline for an adjustment to be considered.

The FPH Reasonable Adjustment Policy states that adjustment offers will be finalised three weeks before the exam as an absolute deadline. Where possible, adjustment offer outcomes will be sent by 20th August for early submissions and 12th September 2025 for final deadline submissions. Wherever possible, the Exams Coordinator will be in touch sooner than this date.
